Preserving our assets

Peatlands are one of Scotland's most important natural assets. They store carbon, provide us with clean drinking water, help to regulate floods, support our wildlife and are part of our heritage.

In 2013 the Scottish government pledged £15 million to support peatland restoration. In 2015 this will be distributed through SRDP in Scotland and will mostly cover capital costs.

The UK Peatland Code has been developed to facilitate private sponsorship of peatland restoration on top of SRDP funding to make restoration more financially attractive and to provide continued maintenance payments.

The International Union for the Conservation of Nature (IUCN) is overseeing the Peatland Code. We would like to know:

•What sort of management options are most appropriate in your area

•What would be a fair price for carrying out restoration management

•How best to organise the funding

The results of this study will be used in consultations with the private sector to obtain funding via the Peatland Code.

We need your help to figure out a way to secure the future of Scotland's peatlands.
